The accompanying unaudited consolidated financial results includes unaudited interim financial results and other unaudited financial information in respect of one subsidiary, which have not been reviewed by their auditors, whose interim financial results reflect total revenues of Rs. 0 lakhs and Rs. 0 lakhs, total net loss after tax of Rs. 247 and Rs. 701 and total comprehensive profit of Rs. 0.11 lakhs and Rs.0.76 lakhs, for the quarter and the Nine month ended December 31, 2022 respectively as considered in the unaudited consolidated financial results, whose interim financial statements / financial information / financial results have not been reviewed by us.
