Bail denied in minor rape case

THANE: Thane Sessions Court rejected bail for a 39-year-old accused of raping his minor stepdaughter, citing evidence tampering. The 15-year-old victim, pregnant due to repeated assaults, was threatened into silence. Despite a filed charge sheet, the court noted a strong case under the POCSO Act, with DNA reports pending. The accused claimed false implication, but bail was denied due to the offence's severity.

BMC worker duped

MUMBAI: BMC worker Vinod Hella lost Rs69 lakh in a fake rehab housing scam. Five including estate agent Abdul Sheikh were booked. Agents promised a flat in Rehab Towers for huts using forged documents. Police registered a case under IPC sections 420 and 34 after Hella filed a complaint.

SAFETY AT RISK | Blasting continues near the Tata Cancer hospital despite monsoon

Illegal quarry dust threatens patients

A stone quarry located just behind the Tata Cancer Hospital at Kharghar has been found to be illegal according to information obtained through the Right to Information (RTI) Act. The RTI was filed after the Chief Minister's Office (CMO) forwarded a complaint email to the Raigad Collector, following appeals by activists to stop the activity.

"The Panvel Tahsildar's office, under whose jurisdiction the site falls, has categorically stated that no licenses have been issued for any stone quarrying in the area," said BN Kumar, director of the foundation.

Activists observed that despite the monsoon season, blasting and crushing activities continue unabated, raising serious environmental and public health concerns. Both the Foundation and the Kharghar Hill and Wetland Forum have accused authorities of turning a blind eye to the hazardous quarrying activity.

"It shocking that such large-scale, polluting activity is continuing right under the nose of the authorities," said

Jyoti Nadkarni, convener of the Kharghar Hill and Wetland Forum, "Dump trucks loaded with stone chips constantly move in and out, and the air is thick with dust—completely unfit for cancer patients and local school children."

Kumar emphasised the risks posed to the Advanced Centre for Treatment, Research and Education in Cancer (ACTREC), which houses high-precision diagnostic and treatment equipment highly sensitive to dust. He recalled that ACTREC's director had previously raised similar complaints, leading to a temporary halt in quarrying,

which has now resumed with greater intensity.

Activists observed that stone dust from the site is spreading into nearby residential sectors and even the hospital premises, threatening sensitive medical equipment and vulnerable cancer patients. The proximity of the quarrying activity to the under-construction Kharghar-Turbhe tunnel and the Pandavkada waterfalls eco-tourism zone adds to the concern.

"Continuous blasting is weakening the hill's structure, increasing the risk of landslides," Nadkarni warned. "We have already witnessed disasters at Irshalgad and the Parsik Hills—must we wait for another tragedy?"

The activists have urged the Maharashtra Pollution Control Board (MPCB) to intervene and conduct a comprehensive Environmental Impact Assessment (EIA). They reminded authorities of the National Green Tribunal's mandate requiring environmental clearance for quarry operations.

"This is not just a local issue—it's about protecting lives, ecology, and public infrastructure," Kumar stressed. "The rampant quarrying must be stopped immediately."

Dombivli receptionist assaulted

The Manpada police have booked a man for allegedly assaulting and abusing a female receptionist at a doctor's clinic in Dombivli on Monday evening.

A video of the incident went viral on social media, after which local Maharashtra Navnirman Sena (MNS) members visited the police station and demanded the immediate arrest of the accused.

The incident occurred on Monday evening when the

accused, Gokul Jha, 25, along with his family, brought an unwell girl to a pediatric clinic located in Nandivli, Dombivli, for a check-up. According to police, the accused and his relatives waited at Dr. Aniket Palandhi's clinic for a long time. When the accused saw the doctor speaking with a medical representative (MR), he became angry and tried to enter the doctor's cabin forcefully.

The receptionist, identified as Sonali Kalasare, stopped him and informed him that it was not yet his turn and requested him to wait.

Enraged, he allegedly began abusing her and then physically assaulted her by kicking her and pulling her hair. In the viral CCTV footage, the accused can be seen entering the clinic, kicking the receptionist, grabbing her hair tightly, and dragging her. Other patients, along with the doctor and the accused's relatives, intervened and managed to stop the assault and remove him from the clinic.

Following the incident, Kalasare approached the police station and lodged an FIR against the accused.

Iphone bricks, Mumbai woman sues Apple

A Chembur-based woman, Reema Chawla, has filed a case against Apple Inc. after her iPhone 14 Plus, purchased for Rs80,411 in 2023, became non-functional two years later following a software update.

The phone suffered continuous auto-restarts and entered a permanent boot loop, resulting in the loss of critical data without backup. Despite multiple visits to Apple's service centre, the issue remained unresolved.

Chawla alleges she faced callous behaviour from service staff, who provided exorbitant repair estimates of Rs47,400 for a mid-system change and Rs74,500 for a unit exchange, without guaranteeing a resolution. A notification about a "New Back Glass Detected" appeared after formatting, despite no such replacement occurring. She also claims Apple withheld its official complaint email and failed to address her concerns. Chawla discovered other iPhone 14 Plus users faced similar issues—its about protecting lives, ecology, and public infrastructure," Kumar stressed. Apple did not respond to inquiries within 24 hours.



Paws in peril: Dog rescued

A dog trapped for nearly 2 days in a 150-200 feet deep gorge near Landscape Point in Mathuran was rescued by the Sahaydri Mitra Emergency Social Organisation. The risky rescue happened Monday evening around 3-5:30 PM. Locals heard the dog crying for help over the weekend. "The biggest challenge was winning the dog's trust," said Vaidhva Nalk from the Mathuran Sahaydri Rescue Team. The team lured the dog with biscuits, secured him with a harness, and brought him up safely. The dog, a stray, was uninjured.

Teen molested in Bandra West

MUMBAI: A 16-year-old girl was molested in a moving autorickshaw in Bandra West on Monday. The assailant, who entered at a traffic signal, threatened the driver with a knife and fled after the assault. Bandra Police arrested the suspect on Tuesday using CCTV and a sketch. Case filed under BNS and POCSO Act; probe ongoing.

Elderly killed

MUMBAI: A speeding trailer hit and killed 64-year-old scooter rider Intiaz Shikalgar near Margaon Dock on July 21. The trailer driver, Mohammad Yunus Ahmad Khan, was booked for negligent driving. Shikalgar was rushed to KEM Hospital where he was declared dead. An investigation is on.

School vandalism

MUMBAI: On July 21, 11 members of a defeated trustee group allegedly vandalized Yogi Raj Shreekrishna Vidyalay in Sakinaka after losing a school committee election. The school, on Salsapad, 90 Feet Road, saw its office damaged. Sakinaka Police have registered a case and are investigating.

Nalasopara murder

PALGHAR: Chaman Devi and her lover Monu Sharma were arrested in Pune for murdering Devish husband, Vijay Chauhan (32), and burying him in their Nalasopara home. The crime, linked to an extramarital affair, was uncovered after a missing person report. Pelhar Police found the body Monday; investigation continues.

Teacher gets bail

MUMBAI: A POCSO court on Tuesday granted bail to Bipasha Kumar, a former teacher at Bombay Scottish School, who was arrested for allegedly sexually assaulting a student. The case, filed in 2023, was moved for nearly a year. It imposed several conditions on Kumar, including a prohibition on contacting the victim.
